- 2) Room attendants' salary Rs. 46, 575
- 3) Lighting Rs.27, 700
- 4) Power charges Rs.13, 850
- 5) Repairs and maintenance Rs. 21, 000
- 6) Decoration Rs.25, 000
- 7) General expenses Rs. 38, 275
  - 8) Depreciation on
    - a) Building @ 5% on cost of building of Rs. 7 lakhs
- b) Furniture @10% on cost of furniture of Rs. 1.5 lakhs.

### Other information;

- i)The rent of 'A' type rooms is to be fixed as one and half times of the 'B' type rooms.
  - ii) There are 10 'A' type rooms and 15 'B' type rooms in the hotel.
- iii) Normally 60% of 'A' type rooms and 80% of 'B' type rooms are occupied in summer and in winter 20% of 'A' type rooms and 40% of 'B' type rooms are occupied.
- iv) Summer may be assumed for 7 months and winter for 5 months in a year.
- v) Normal days in a month may be taken as 30 days.
- vi) Profit on cost is 25%.
