Rules for eligibility for Election to the Students' Council for the year 2025-2026

- 1) Students' Council for the year 2025-2026 will consist of 23 members as follows: -

- A) General Secretary (1 No.)
- B) Cultural Secretary (1 No.)
- C) Sports Secretary (1 No.)
- D) Ladies Representatives (3 Nos.)
i.e., one each for F.Y.B.COM/F.Y.B.C. A
S.Y.B.COM/S.Y.B.C. A
T.Y.B.COM/T.Y.B.C. A

- E) Divisional Representatives (17 nos.) i.e., one each for

F.Y.B.COM	DIVISION A, B, C,	----- (3 Nos.)
S.Y.B.COM	DIVISION A, B, C, D	----- (4 Nos.)
T.Y.B.COM	DIVISION A, B, C, D	----- (4 Nos.)
F.Y.B.C.A	DIVISION A, B,	----- (2 Nos.)

- 2) The students of respective divisions can contest for the Post of Divisional Representatives (DR). Divisional Representatives will be elected by the students of the respective division.
- 3) Only Female students are eligible to contest for the post of Ladies Representatives (LR). Ladies Representative will be elected only by female students of the respective Class.
- 4) In case of candidates contesting for Sports Secretary (S.S), should have played in Inter- Collegiate Tournaments.
- 5) The General Secretary (G.S) and Cultural Secretary (C.S) will be directly elected by all students. All bonafide students of the college (except Sports Secretary and students for Divisional Representative and Ladies Representative) are eligible to contest for these posts.

- 6) One candidate can contest for one post only.
- 7) A Student contesting the election should not have attained the age of 22 years on the date of election.
- 8) A student wishing to contest the election must have cleared all the dues in fees.
- 9) Candidates contesting from T.Y.B.COM / B.C.A. and S.Y.B.COM / B.C.A. should not have any backlogs.
- 10) Candidates should not have any Political affiliation.
- 11) In case no candidate contests for the post of GS, CS, LR and DR, the Principal will nominate the candidate for the respective posts.
- 12) A student should clearly specify on nomination paper the post for which he/she is contesting.
- 13) The proposer and seconder have to be from same class for the post of L.R. Name of candidate for LR should be proposed and seconded by female students only.
- 14) The proposer and seconder have to be from same division for the post of DR.
- 15) A Student who proposes one candidate cannot second any other candidate and student who seconds one candidate cannot propose any other candidate.
- 16) Incomplete and incorrect form will be treated as invalid.
- 17) Campaigning should be limited to bonafide. students only and should end one-day prior to election. Any Violation can lead to disqualification of the candidate.
- 18) Interference of outsiders who are not bonafide students is prohibited.

- 19) Use of threats, unfair means, pressure tactics may disqualify a candidate, if found guilty.
- 20) Candidates using unfair means for canvassing will be held ineligible for the election and their candidature will be cancelled.
- 21) No Rally of any kind within and outside the campus before and after the elections. Violation of this will lead to disqualification of the candidate.
- 22) Use of College building walls, blackboards for canvassing are strictly prohibited.
- 23) Any type of misbehaviour on the part of successful candidates or their supporters in the premises of the college will result into cancellation of the election of the candidate and the candidate is liable for disciplinary action.
- 24) Students should produce Library Card/FEE Receipt as the proof of their identity during record of votes and filing of nomination.
- 25) The election to the Students' council shall be held by Ballot and in accordance with the system of simple majority of Votes.
- 26) In case of tie between candidates, decision will be taken on the basis of lots drawn.
- 27) Meetings of the Students' Council will be held at regular intervals. All elected members should attend these meetings regularly if any member fail to attend 02 successive meeting will be removed and new member will be nominated.
- 28) In all matters regarding election, the decision of the Principal is final and binding.
